This letter of intent shall indicate which office and the term for which the individual wishes to run. The Board reserves the right to invalidate the letter of intent if the office and term are not indicated.

Every elector of the Town who shall have resided within the Fire District for a period of thirty (30) days preceding the Election and who is a duly registered voter under Permanent Personal Registration in the County of Broome shall be qualified to vote at said Election.
